



















The federal government has transitioned from the use of "DUNS Numbers" to a new Unique Entity Identifier (also referred to as "SAM UEI", or just "UEI") through <u>SAM.gov</u> as the primary identifier for tracking where federal grant dollars flow. This new SAM UEI is required of all state, regional, and local agencies, along with nonprofit organizations that receive federal funding; a SAM UEI is also required of organizations that are subgrantees of state, regional, and local agencies. Since Virginia Commission for the Arts receives a grant from the National Endowment for the Arts, it requires all VCA applicants (except individuals) to have a SAM UEI. Acquiring a SAM UEI is a free process. Be wary of scams that may try to impersonate SAM.gov or may try to scam your organization into paying for a UEI.

As a potential subgrantee receiving federal funds through the VCA's Partnership Agreement with the National Endowment for the Arts, you must obtain a UEI to apply for VCA funding.

Already registered in SAM.gov?

Great – you are good to go! Organizations that are already registered with <u>SAM.gov</u> have automatically been assigned a new SAM UEI.

Not yet registered in SAM.gov?

To obtain your organization's SAM UEI, you will need to request one through <u>SAM.gov</u> – you can do so by visiting <u>this page</u> and clicking the button that says "Get Unique Entity ID." Note: you will be prompted to log in or create an account through LogIn.gov in order to proceed. Please note that you do not need to complete a full registration ("Register Entity") with SAM.gov in order to get a SAM UEI. Acquiring a SAM UEI is a free process.



BASIC ELIGIBILITY



BASIC ELIGIBILITY | VIRGINIA ORGANIZATIONS



- are nonprofit and exempt from federal income tax under Section 501(a), which includes the 501(c)(3) designation of the Internal Revenue code, or are units of government, or are educational institutions, or are local chapters of tax-exempt national organizations;
- must have a valid Unique Entity Identifier (UEI) number, a 12-character alphanumeric value assigned, managed, and owned by the federal government through Sam.gov.(this excludes individual artists);
- will remain in operation for the duration of the grant cycle to receive and apply the funds;
- **produce, present, or support in Virginia**, dance, literary arts, media arts, music, theater, visual, and related arts;
- comply with Title VI, Section 601, of the Civil Rights Act of 1964 which states that no person, on the grounds of race, color, or national origin, shall be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving federal financial assistance.
- comply with Title IV, Section 1681, of the Education Amendments of 1972, and the Age Discrimination Act of 1975, Section 6101, which prohibit discrimination on the basis of sex or age;
- comply with Section 504 of the Rehabilitation Act of 1973, as amended, and the Americans with Disabilities Act of 1990, which state that no otherwise qualified person shall, solely by reason of a handicap, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving federal financial assistance;
- are not under current debarment or suspension from federal funding;
- have **no past due Final Reports to the VCA** at the time of application

BASIC ELIGIBILITY | INELIGIBLE ACTIVITIES

The Virginia Commission for the Arts does not fund:

- Activities restricted to an organization's membership
- Expenses related to parties, receptions, fundraising events/benefits, etc.
- Endowments or capital campaigns
- Activities that are primarily religious in purpose
- College or university-based projects that are part of a required course or curriculum, that do not involve and serve a significant non-student population, or that are for activities that are otherwise available in the community
- General operating support for historic celebrations or community promotional activities


- Fines and penalties, bad debt costs, or deficit reduction
- Arts activities / programs that have already started or otherwise occurred
- Activities or programs that take place outside Virginia
- Vocal, dance and musical ensembles that perform primarily pop, Broadway, or barbershop music, or that focus primarily on competitions

Lobbying | No part of a Virginia Commission for the Arts grant shall be used for any activity intended to influence a member of Congress or the General Assembly, to favor or oppose any legislation.




DESCRIPTION

This Virginia Touring Grant program supports touring by Virginia performing artists and ensembles within the state. The touring activities are restricted to those listed in the Commission's annual Touring Artist Roster.

Any nonprofit organization meeting the Basic Eligibility criteria can apply to receive a Virginia Touring Grant to support these activities. Grants are made to the presenter, not to the touring artist(s). Touring artists apply to be listed on the Touring Artist Roster, with a set dollar amount reserved to support their touring.

To be eligible for funding, performances must take place in Virginia but outside of the performer's home base. Any activity underwritten with Commission touring assistance funds must be open to the public, and the presenter must provide community-wide publicity. Elementary and secondary schools, senior living facilities, correctional facilities, and hospitals are exempt from this Commission requirement.

WHO CAN APPLY

Virginia performing artists and performing arts ensembles. Individual students or organizations whose members are primarily Pre-K-12 or undergraduate college students are not eligible for inclusion in the Touring Artist Roster.

Artists awarded inclusion onto the Touring Artist Roster are given an allocation that is used to fund Virginia Touring Grants



The Virginia Commission for the Arts awards touring support grants to presenters of a particular artist/ensemble on a firstcome, first-served basis from that artist's and/or ensemble's allocation. Grant award letters are generally emailed two weeks after receipt of each presenter's application by the Commission.





WHO CAN APPLY

- Virginia nonprofit organizations | arts organizations, community centers, theatres, hospitals, nursing homes, service organizations, etc.
- Units of local or tribal government | libraries, parks and recreation departments, etc.
- Educational institutions | PreK-12 schools, colleges and universities, public and private
- Must present activities in ADA compliant facilities
- Must have a valid UEI number

ELIGIBLE ACTIVITIES

- Programs taking place in Virginia from June 1, 2023
 June 15, 2024*
- Programs listed in the Touring Artist Roster which take place at least 30 miles from home base of the artist/ensemble
- Programs should be open to the public, and the presenter must provide community- wide publicity. Elementary and secondary schools, senior living facilities, correctional facilities, and hospitals may be exempt from this requirement
- Touring assistance may not be used for fundraising events

***NOTE** If a performance takes place June 16-30, the presenter will apply for funding in the next grant cycle. Please have the presenter contact VCA staff for more information.



- **SCHEDULING** Artists and presenters are responsible for scheduling events, negotiating fees, and all other arrangements.
- **VCA SUBSIDY** | The amount of the VCA subsidy may be negotiated by artists and presenters at any level up to, but not exceeding, 50% of the negotiated performance fee for a particular event.
- **FEES** The fees listed may not include expenses such as the artist's transportation to the presenter's community, meals, lodging, and related expenses. Presenters should clarify what additional expenses may or may not be included in the fee.
- **TECH** Artists should confirm all technical requirements with the presenter prior to negotiating the terms of the contract.
- **CHANGES** Any changes in the contract or contact information by either the presenter or artist must be submitted to the VCA in order to update the application and online Touring Artist Roster.



- **EXECUTION** Presenters must execute a contract with each artist/ensemble. The contract must be signed by both the artist or the artist's representative and the presenter, with a signed copy kept on file for future reference.
- **CLARITY** A well-written contract can be simple and concise and will clarify each party's requirements and expectations about the event. It should specify items such as technical and publicity requirements; the date, time, and place of the event; the artist's fee to be paid by the presenter; the anticipated Commission touring assistance grant award to the presenter to be applied toward the total fee; and all other special requirements or considerations.
- **VCA CLAUSE** All contracts must include a clause stating:

This contract is contingent upon receipt of a Virginia Touring Grant award in the amount of



- WAITLIST If an artist/ensemble listed on the Touring Artist Roster has used all of its original allocation prior to December 1, it may book additional performances and encourage the presenters to apply to the Commission's "wait list" on a first-come first-served basis for funds which have gone unused by other artists/ensembles.
- **NO GUARANTEE** It is the responsibility of the artist/ensemble to explain that there is no guarantee of funding in this situation.
- PERFORMANCE DATES | Waitlist performances must take place between December 2 and June 15 of each touring season.

NOTE:

Touring ensembles that receive an allocation of \$25,000 or more may not apply for waitlist funds.



VIRGINIA TOURING GRANT AWARD

- Presenters may apply online for a 1:1 match of up to 50% of the performance fee only subject to the overall limit for each touring artist/ensemble.
- Virginia Touring Grant award amounts are a minimum of \$100 and maximum of \$7,500 per event.
- Funds from other Commission programs may not be used to match any portion of a Virginia Touring Grant award.

VIRGINIA TOURING GRANT PAYMENT

- Grant Awards over \$500
 The Commission will send
 85% of the grant award to the
 presenter before the
 scheduled event IF they apply
 at least 4 weeks in advance.
 Otherwise, awards will be paid
 in full 30 days after the receipt
 of the final report.
- Grant Awards of \$100 to \$499 | Payment will be made in full approximately 30 days after the Commission has received the final report.
- Awards for July Performances | Will be made in full 30 days after the receipt of the final report, but no earlier than August 1.


PRESENTER REQUIREMENTS

- The presenter must acknowledge and utilize VCA/NEA logos on all published materials.
- The Commission will pay the final 15% of the grant after receiving a final report.
- Presenters must submit final reports within 30 days after each event. Final report forms can be found on the presenter's Dashboard.

To be eligible for funding, performances must take place in Virginia but outside of the performer's home base. Any activity underwritten with Commission touring assistance funds must be open to the public, and the presenter must provide community-wide publicity. Elementary and secondary schools, senior living facilities, correctional facilities, and hospitals are exempt from this Commission requirement.

FOR PERFORMERS AND ENSEMBLES SEEKING TO BE LISTED ON THE TOURING ARTIST ROSTER

ELIGIBLE APPLICANTS

Virginia performing artists and performing arts ensembles. Individual students or organizations whose members are primarily Pre-K-I2 or undergraduate college students are not eligible for inclusion in the louring Artist Roster.

ELIGIBLE ACTIVITIES

- All bookings for Performing Arts Touring Assistance must take place 30 miles outside of the home area of the touring artist(s)/ensemble.
- Programs should be open to the public, and the presenter must provide community-wide publicity. Elementary and secondary schools, senior living facilities, correctional facilities, and hospitals may be exempt from this requirement.

DEADLINE FOR ARTISTS TO APPLY FOR INCLUSION ON THE TOURING ARTIST ROSTER

Online application is due July 15, 2023, by 5:00 p.m. EST, for the touring season of July 1, 2024, to June 15, 2025.



DESCRIPTION

Teaching Artists are committed to the development of their own artistic practice as well as their teaching pedagogy with the desire to share their knowledge through residencies and workshops. They are knowledgeable in the techniques and content of their disciplines and are adept at developing and implementing audience-specific arts curriculum. Although the VCA promotes the Teaching Artist Roster to applicants and others, the Commission does not guarantee contract work to our Teaching Artists.

ABOUT THE PROGRAM | ELIGIBILITY

WHO CAN APPLY

- 18 years of age or older at the time of application
- a resident of VA, DE, KY, MD, NC, PA, TN, WV, and/or the District of Columbia
- professional artist with expertise in one or more disciplines
- skilled in working with children, youth, teachers, adults, seniors, veterans, and/or other populations
- committed to differentiated instruction and effective teaching methods to reach all learners
- individual Teaching Artists as well as nonprofit organizations that provide educational programming and employ Teaching Artists are eligible to apply

NOTE: Full-time students are ineligible to apply for the Teaching Artist Roster.





COMMUNICATION FOR THE STATE

DESCRIPTION

The Arts in Practice grants program provides support of up to \$1,500 (15 percent cash match) to eligible Virginia Pre–K-12 schools, nonprofit organizations, and units of local and tribal government for short-term residencies focused on participatory and experiential learning conducted by professional teaching artists. VCA Teaching Roster Artists who are permanent Virginia residents can apply for up to two Arts in Practice grants per grant cycle. Funding is available on a first-come-first-served basis and applications will be reviewed by staff in the order in which they are received. The shape and schedule of the residency is up to the school/organization and the artist. An intensive residency may occur over one to three days, or it may be appropriate to have more residency activities of shorter duration, such as two hours a week for six weeks. For residencies that are more than 20 hours, please apply for the Education Impact Grant.



Arts in Practice | Nonprofit organizations and units of local and tribal government can apply to bring in teaching artists for educational programming twice a year. If applying for GOS funding, these entities cannot apply to Arts in Practice. VCA Teaching Artists from the Teaching Artist Roster can apply twice a year.

Education Impact | Similar to Arts in Practice, however, only nonprofit organizations and units of local and tribal government can apply.







Artists should confirm with Commission staff the select disciplines each year.

- Artists may receive only one fellowship from the Commission within any four-year period




