

# **Education Impact Grants**

 Applications utilizing VCA Teaching Artists will be reviewed in-agency only. If utilizing an artist outside of the Roster, the application will be reviewed by an Advisory Panel.

### **Arts in Practice Grants**

- Applicants must select an artist from the VCA Teaching Artist Roster, aligning policy with Virginia Touring Grants and Touring Artist Roster
- Awards increase from \$1,500 to up to \$2,000
- Will open May 1 for the grant period of July 1, 2024 June 15, 2025



# BASIC ELIGIBILITY REQUIREMENTS





# **Applicants applying for a Virginia Commission for the Arts grant must:**

- Be a nonprofit and exempt from federal income tax.
- Have a valid **SAM.gov** Unique Entity Identifier (UEI) number.
- Remain in operation for the duration of the grant cycle to receive and apply the funds.
- Produce, present, or support the arts in Virginia.
- Not be under current debarment or suspension from federal funding.
- Have no past due Final Reports to the VCA at the time of application.

- Comply with **Title VI**, **Section 601**, **of the Civil Rights Act of 1964** which states that no person, on the grounds of race, color, or national origin, shall be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving federal financial assistance.
- Comply with Title IV, Section 1681, of the Education
  Amendments of 1972, and the Age Discrimination Act of 1975,
  Section 6101, which prohibit discrimination on the basis of sex or age.
- Comply with Section 504 of the Rehabilitation Act of 1973, as amended, and the Americans with Disabilities Act of 1990, which state that no otherwise qualified person shall, solely by reason of a handicap, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving federal financial assistance.

# **INELIGIBLE ACTIVITIES**





# The Virginia Commission for the Arts does not fund:

- Activities restricted to an organization's membership.
- Expenses related to parties, receptions, fundraising events/benefits, etc.
- Endowments or capital campaigns.
- Activities that are primarily religious in purpose.
- College or university-based projects that are part of a required course or curriculum, that do not involve and serve a significant non-student population, or that are for activities that are otherwise available in the community.
- General operating support for historic celebrations or community promotional activities.

- Fines and penalties, bad debt costs, or deficit reduction.
- Arts activities / programs that have already started or otherwise occurred.
- Activities or programs that take place outside Virginia.
- Vocal, dance and musical ensembles that perform primarily pop, Broadway, or barbershop music, or that focus primarily on competitions.

**Lobbying** | No part of a Virginia Commission for the Arts grant shall be used for any activity intended to influence a member of Congress or the General Assembly, to favor or oppose any legislation.

# PARTNERSHIP GRANTS



# General Operating Support for Medium and Large Organizations | GOS

\$2,500 - \$100,000

- Medium to large arts organizations with annual income of \$150,000+
- 3 previous years of programming and 3 programs per year
- Long form applications are reviewed by a statewide Advisory Panel. Short form applications are reviewed by VCA staff.
- FY25 GOS application assignments can be found HERE
- May not apply for OSS, Community Impact, and/or Arts in Practice grants

### **Deadlines:**

FY25 GOS Short Form: February 1 FY25 GOS Long Form: March 1

# **Operating Support for Small Organizations | OSS**

### \$2,500

- Small arts organizations with annual income of less than \$150,000
- 2 previous years of programming and 3 programs per year
- Applications are reviewed by VCA staff
- May not apply for GOS and/ or Community Impact grants

**Deadline:** March 1

# **Creative Communities Partnership Grants | CCPG**

### Matching grant up to \$4,500

- Independent cities, towns, counties, or tribal governments in Virginia
- Sub-grants to independent, ADA-compliant arts organizations for arts activities in the locality.
- Local or tribal governments that have not approved their budgets by the grant deadline may apply conditionally
- Grants may not be used to supplement school arts budgets or arts programming by local governments or to match payments paid to performers for specific performances.
- Applications are reviewed by VCA staff
- Deadline: April 1

# Community Impact Up to \$5,000

- New and innovative art-based projects or services that reach and impact Virginia communities including those that are underserved, under-resourced, or underrepresented
- nonprofit organizations; universities/colleges; units of local and tribal government
- 1:1 cash match
- Applications are reviewed by a statewide Advisory Panel

**Deadline:** March 1



# Education Impact Up to \$5,000

- Long-term residencies/programs with Virginia students, educators, and other adult populations in both traditional and non-traditional learning environments
- nonprofit organizations; federally tax-exempt schools; units of local and tribal government
- 1:1 cash match
- Applications are reviewed by a statewide Advisory Panel

**Deadline:** April 1

# **VA250 Impact Grant**

Up to \$5,000 non-matching

The Virginia Commission for the Arts in partnership with the Virginia American Revolution 250 Commission (VA250), is thrilled to unveil the VA250 Impact Grant. This initiative is set to fund dynamic arts programs that spark a **'Revolution of Ideas,'** celebrating the 250th Anniversary of the American Revolution and the enduring spirit of innovation that founded our nation.

**VA250 Impact Grants** will bolster a wide array of artistic endeavors, from thought-provoking visual arts exhibitions to dynamic live performances, and from interactive public art installations to educational workshops taking place between July 1, 2024, and June 30, 2025.

### **Eligible Applicants**

- Virginia units of local and tribal government, including libraries and departments of parks and recreation
- Public educational institutions

### **Eligible Expenses**

- Artist / Speaker / Educator Fees
- Marketing and Promotion of the Program
- Supplies / Equipment Fees
- Venue Rental





# ARTIST ENGAGEMENT GRANTS





# Virginia Touring Grants Up to 50% of performance fees

- Provides up to 50 percent of the performance fee for touring programs listed on the VCA Touring Artist Roster
- Performances taking place July 1, 2024 June 15, 2025
- nonprofit organizations; federally tax-exempt schools; units of local and tribal government
- Payments are made to the Presenter who is responsible for compensating the touring artist/ensemble in full
- Applications are reviewed by VCA staff

Applications open: March 1

**Deadline:** December 1



# Arts in Practice Up to \$2,000

- Short-term (under 20 hours) hands-on, participatory residencies/workshops led by artists on the VCA Teaching Artist Roster
- Activities taking place July 1, 2024 June 15, 2025
- nonprofit organizations; federally tax-exempt schools; units of local and tribal government
- 15 percent cash match
- Applications are reviewed by VCA staff

**Applications open:** May 1

**Deadline:** May apply two times per grants cycle before April 15,

or until funding is exhausted

# **Touring Artist Roster**

- Inclusion onto the statewide Touring Artist Roster, which serves to provide Virginians with enriching arts experiences that extend beyond their immediate communities
- Virginia-based performing artists and performing arts ensembles. Students or organizations that primarily Pre-K-12 are ineligible to apply.
- Touring allocation for the FY25 touring season (July 1, 2025
   June 15, 2026)
- Virginia Touring Grant performances must take 30 miles outside the home base of the artist/ensemble
- Applications are reviewed by a statewide Advisory Panel

**Deadline:** July 15



### **Teaching Artist Roster**

- Inclusion onto the statewide Teaching Artist Roster, which serves as an online resource for Arts in Practice and Education Impact Grants
- 18+ teaching artists from VA, DE, KY, MD, NC, PA, TN, WV or DC who are skilled in various age groups and populations. Both individuals and nonprofit organizations that provide educational programming may apply.
- Arts in Practice grants are required to select artists from the Teaching Artist Roster. Utilizing VCA Teaching Artists for Education Impact Grants is optional.
- Applications are reviewed by a statewide Advisory Panel

**Deadline:** July 15

# ARTIST FELLOWSHIP GRANTS



# **Artist Fellowships**

Up to \$5,000

- Recognizing the creative excellence of individual Virginia artists and support their pursuit of artistic excellence
- 18+ legal Virginia residents (drivers license, income taxes, registered voter)
- Disciplines rotate yearly and are announced each summer
- A limited number of Artist Fellowships are available to professional creative artists living in Virginia. Funding is highly competitive.
- Applications are reviewed by a statewide Advisory Panel

**Deadline:** October 1


All applications must be submitted via Foundant, the VCA's online grants system. Applications are due in Foundant by 5:00 p.m. EST on the date published for each individual grant program. No paper applications are accepted – no exceptions!

Once you or your organization is registered in Foundant, you will have created an online profile and account. You can log on anytime to apply for funding opportunities, review active grants, view past submissions, request funds, and submit final reports. Simply enter your username and password to sign in.

# SHARING NOT JUST THE WHAT, BUT THE HOW



- Include metrics, timelines, processes
- Use strong verbs that describe implementation:
- Bringing on ...
- Growing ...
- Engaging ....
- Collecting ....
- Evaluating ....
- Address evaluation tools and how they affect decision making | anecdotal, testimonial, and statistical




# **TELLING THE STORY**



- Be descriptive
- Remove all language that is vague, ambiguous, or non-transparent
- Demonstrate intentionality
- Include a success story

# "What are we looking at?"



# SELECTING THE RIGHT ARTISTIC EXCELLENCE EXAMPLES



- Art can speak for itself in the best samples
- With video footage content, include descriptors and time marks
- Properly name photographs as identifiers
- Abide by the instructions and do NOT include marketing pieces (produced brochures, flyers, invitations, etc.)
- Lean into organization-specific programming (i.e. for a local theatre, include a review of the community play produced versus a review of a blockbuster film shown)

# "If you're going to say it, describe it."

"It is vulnerable without documentation."



# PROVIDING ANSWERS IN THE ALLOTTED SPACE



- A lack of details / support narrative or documentation equates to a lack of understanding the organization or program
- Mentioning a challenge (deficit, staff turnover, low box office sales, etc.) is often beneficial, but an explanation on how to address this challenge is important
- Saying a program, such as *professional development* or *arts education*, needs a descriptor professional development / arts education for who? What intended audience? How many attendees? What programming? How will you evaluate?

# "Impact is more than a headcount."



# **DEMONSTRATING IMPACT**



- Incorporate quantitative and qualitative data
- Provide an impact report link / statement of impact
- Remember that not all populations carry the same profiles | veterans, students, incarcerated, underserved, etc.

# GIVING YOUR APPLICATION STRUCTURE



- Avoid cutting and pasting the same information in multiple places
- Check for typos
- Consider length of staff bios and Board bios
- Give weight to your narrative
- specificity
- # of ... (donors, patrons, students, etc.)
- names of advisors / consultants engaged




#### TELLING YOUR STORY IN THE NUMBERS



- Ensure the descriptive narrative aligns with the line items of the budget
- Document in-kind gifts and services, which oftentimes demonstrates strong community support
- Include staff time and additional costs
- Run your numbers miscalculations will not do you any favors



- Focus on the relevancy of *your* organization relevancy to your region, your audience, your role in the community, etc.

- Familiarity and understanding of a wide variety of arts events in their communities
- High level of articulation of thought
- Willingness to offer opinions and work in a committee setting
- Contribute the time necessary to review grant applications and to understand the Commission programs and guidelines
- Ability to attend a one-day Advisory Panel screening session
- Access to a laptop computer for Advisory Panel application review





