



## 5 KEY UPDATES TO FY26 GUIDELINES FOR FUNDING



- GOS | increased minimum funding levels to \$3,500 (currently \$2,500)
- GOS | Final Report Part II will be due October 1<sup>st</sup> (currently December 1<sup>st</sup>)
- OSS | income range \$20,000 \$150,000 (currently \$10,000-\$150,000)
- OSS | cumulative debt from previous two years may not exceed 20%
- Education Impact | eliminated to focus on Community Impact and Arts in Practice




BASIC ELIGIBILITY

## BASIC ELIGIBILITY REQUIREMENTS



#### **Applicants applying for a Virginia Commission for the Arts grant must:**

- Be a nonprofit and exempt from federal income tax.
- Produce, present, or support the arts in Virginia.
- Have a valid <u>SAM.gov</u> Unique Entity Identifier (UEI) number .
- Remain in operation for the duration of the grant cycle to receive and apply the funds.
- Not be under current debarment or suspension from federal funding.
- Comply with **federal non-discrimination laws**, including:
- Title VI of the Civil Rights Act (race, color, national origin).
- Title IX of the Education Amendments (sex).
- Age Discrimination Act (age).
- Section 504 of the Rehabilitation Act and ADA (disability)
- Have no past due Final Reports to the VCA at the time of application.



## **INELIGIBLE ACTIVITIES**



#### The Virginia Commission for the Arts does not fund:



- Activities restricted to an organization's membership.
- Expenses related to parties, receptions, fundraising events/benefits, etc.
- Endowments or capital campaigns.
- Activities that are primarily religious in purpose.
- College or university-based projects that are part of a required course or curriculum, that do not involve and serve a significant non-student population, or that are for activities that are otherwise available in the community.
- General operating support for historic celebrations or community promotional activities.

- Fines and penalties, bad debt costs, or deficit reduction.
- Arts activities / programs that have already started or otherwise occurred.
- Activities or programs that take place outside Virginia.
- Vocal, dance and musical ensembles that perform primarily pop, Broadway, or barbershop music, or that focus primarily on competitions.

**Lobbying** | No part of a Virginia Commission for the Arts grant shall be used for any activity intended to influence a member of Congress or the General Assembly, to favor or oppose any legislation.


All applications must be submitted via <u>Foundant</u>, the VCA's online grants system. Applications are due in Foundant by 5:00 p.m. EST on the date published for each individual grant program. No paper applications are accepted – no exceptions!


#### **How To Apply**

Go to <u>www.vca.virginia.gov</u> and click <u>"Apply"</u> in the top right corner.

Once you or your organization is registered in Foundant, you will have created an online profile and account. You can log on anytime to apply for funding opportunities, review active grants, view past submissions, request funds, and submit final reports. Simply enter your username and password to sign in.



# General Operating Support for Medium and Large Organizations | GOS

\$3,500 - \$100,000

- Medium to large arts organizations with annual income of \$150,000+
- 3 previous years of programming and 3 programs per year
- Long form applications are reviewed by statewide Advisory Panels. Short form applications are reviewed by VCA staff.
- FY26 GOS application assignments can be found <u>HERE</u>
- May not apply for OSS, Community Impact, and/or Arts in Practice grants

#### **Deadlines:**

FY26 GOS Short Form: February 1 FY26 GOS Long Form: March 1

# Operating Support for Small Organizations | OSS

#### \$2,500

- Small arts organizations with annual income of \$20,000 and less than \$150,000
- 2 previous years of programming and 3 programs per year
- Applications are reviewed by VCA staff
- May not apply for GOS and/ or Community Impact grants

**Deadline:** March 1

# **Creative Communities Partnership Grants | CCPG**

#### Matching grant up to \$4,500

- Independent cities, towns, counties, or tribal governments in Virginia
- Sub-grants to independent, ADA-compliant arts organizations for arts activities in the locality.
- Local or tribal governments that have not approved their budgets by the grant deadline may apply conditionally
- Grants may not be used to supplement school arts budgets or arts programming by local governments or to match payments paid to performers for specific performances.
- Applications are reviewed by VCA staff
- Deadline: April 1

# GOS | ARTISTIC EXCELLENCE



#### **Artistic Excellence**

## 30 points

What constitutes artistic excellence may vary in relation to the organization's mission, goals, audiences, and activities. The organization must demonstrate high-quality activities that achieve a distinct artistic vision consistent with the applicant's mission and goals.

#### An organization that receives higher scores in this area will:

- Offer programs and services that are closely aligned with its mission and goals.
- Show breadth and artistic excellence in the quality of programming, including participating artists, works produced or presented, and /or arts services provided.
- Demonstrate strong artistic standards and qualified artistic staff and leadership.
- Priority will be given to organizations that pay artists.

# GOS | OPERATIONAL EXCELLENCE



## **Operational Excellence**

## 30 points

Operational excellence evaluates the organization's capacity to effectively manage its operations and resources as reflected by organizational stability and fiscal position. The organization has a Board-approved strategic planning process that shows evidence that it is maximizing opportunities to generate diversified income. The organization has a strong Board composition, staff qualifications, and clearly articulated roles and responsibilities for each.

#### This review category is broken into three areas:

- 1. Organizational Structure (10 pts)
- 2. Fiscal Responsibility (10 pts)
- 3. Planning and Evaluation (10 pts)

#### An organization that receives higher scores in this area will:

- Operate with qualified and appropriate staff and board structure to carry out programs and activities.
- Provide ongoing learning opportunities for staff, board, and volunteers.
- Show diversified and sufficient income to support stable programming and access to cash to cover occasional shortfalls.
- Demonstrate practical planning strategies for reaching its goals and adapting to the changing environment.
- Have a sound method of evaluating organizational and programmatic effectiveness.

# GOS | COMMUNITY ENGAGEMENT AND ACCESS



# **Community Engagement and Access**40 points

The Commission invests in opportunities for quality arts experiences made available and accessible for the benefit all Virginians. This section seeks to understand the organization's efforts to understand and serve its community, its efforts to be inclusive of individuals, and the impact its programs and services have on communities and artists and patrons served.

#### An organization that receives higher scores in this area will:

- Have a clear understanding of the demographics and community(ies) /audiences it serves.
- Present a solid communications plan and strategies to expand its reach to new and/or underserved, under-resourced, or under-represented audiences.
- Demonstrate a commitment to arts education for Virginians of all ages as part of or beyond the organization's regular programming for the community it serves.
- Make the arts a vital part of community life through accessibility, outreach, advocacy, partnerships, and initiatives that enhance the quality of life in the community, region, and/or state.

# GOS | SCORING AND PRIORITY RATINGS



General Operating Support (GOS) applications are scored on a 100-point scale.

#### **Priority 1 Organizations**

(90 - 100 pts/ average score 90% - 100%) meet the criteria for funding with high scores for artistic excellence, organizational excellence, community engagement, and overall professionalism. These organizations demonstrate best practices in the key areas above and are critical to the cultural life of their communities.

#### **Priority 2 Organizations**

(80 - 89 pts/ average score 80% - 89%) meet the criteria for funding and are critical to the community, although the artistic excellence, organizational excellence, community engagement and access may not be as high as that of the priority 1 applicants.

#### **Priority 3 Organizations**


(70 - 79 pts/ average score 70% - 79%) meet the criteria for funding but (1) are not as critical to the cultural life of their communities as the priority 1 and 2 applicants; do not demonstrate a compelling need for VCA funding; and/or have activities other than the arts as a substantial part of their programming.

## **COMMUNITY IMPACT GRANTS**





#### **Matching Grant up to \$5,000**

#### **Eligible Activities**

- New or expanded performances, exhibitions, screenings, conferences, readings, public art projects, and festivals that focus on engaging new and underserved, under-resourced, and under-represented audiences or communities
- program enhancements that enable participation of individuals with disabilities
- commissions of new works of visual, performing, and media arts
- public art projects that commission an artist for the creation of new work that engage the community in the planning, presentation, and/or fabrication

**Note:** Applications for traditional learning environments, including Pre-K-12 and lifelong learners with identified learning goals may be filed under the Arts in Practice Grant program if applicable. **Community Impact applicants may not apply for GOS or OSS.** 

#### **Eligible Applicants**

- nonprofit organizations, universities/colleges, units of local and tribal government
- 1:1 cash match requirement
- Applications are reviewed by a statewide Advisory Panel

Deadline: April 1

# COMMUNITY IMPACT | EVALUATION CRITERIA



# Artistic Excellence 30 points

Relative to the budget size of the organization, the extent to which the applicant demonstrates a committed effort to provide its audience/community an innovative, impactful, and quality artistic experience.

# **Operational Excellence** *30 points*

The extent to which the applicant can demonstrate sound fiscal and project management.

# **Community Engagement and Access** *40 points*

The extent to which there is an active, twoway engagement between the applicant and the audience/community in the planning, participation, and evaluation of the proposed activity, including intentional strategies to reach new and underserved, under-resourced, and under-represented communities.

# COMMUNITY IMPACT | SCORING AND PRIORITY RATINGS



Community Impact Grant applications are scored on a 100-point scale.

#### **Priority 1 Projects**

(90 - 100 pts/ average score 90% - 100%) are innovative, professional, high-quality projects that fully meet the criteria for funding, will be accessible, well-managed and a cost-effective use of limited state/federal tax funds, and will benefit the cultural life of the community/target audience.

#### **Priority 2 Projects**

(80 - 89 pts/ average score 80% - 89%) meet the criteria for funding, but artistic excellence, operational excellence, community engagement and access are not as strongly evident.

#### **Priority 3 Projects**


(70 - 79 pts/ average score 70% - 79%) meet the criteria for funding, but artistic excellence, operational excellence, community engagement and access are weak.








#### **FY25 Arts in Practice**

Up to \$2,000 15% Cash Match

 Provides up to \$2,000 for participatory residencies/workshops fees led by artists on the VCA Teaching Artist Roster



#### **FY26 Virginia Touring Grants**

Up to 50% of performance fees
1:1 Cash Match

Provides up to 50 percent of the performance fee for touring programs listed on the VCA Touring Artist Roster.

- Virginia nonprofit organizations; federally tax-exempt schools; and units of local and tribal government may apply
- Payments are made to the applicant who is responsible for compensating the VCA Roster Artist in full
- Applicants must submit their requests at least two weeks prior to the start of the activity. Applications are accepted on a first-come, first-served basis and are awarded internally by VCA staff.

#### **APPLICATION DATES**



#### **FY25 Arts in Practice Grants**

- Open: Currently open!
- **Deadline: April 15, 2025**, or until funding is exhausted
- For activities taking place now June 15, 2025
- Applicants may apply twice per grant cycle, subject to the overall limit of \$10,000 per VCA Teaching Artist.
- GOS applicants may not apply


#### **FY26 Virginia Touring Grants**

- Open: March 1, 2025
- Deadline: December 1, 2025
- For activities taking place July 1, 2025 June 15, 2026
- Applicants may apply multiple times per grant cycle, subject to the overall limit for each VCA Touring Artist/Ensemble.

#### PREPARING A STRONG APPLICATION



#### **Craft a Compelling Narrative**

- Highlight your unique value and contributions to arts community.
- Align your organization's mission and activities with your goals and ours.

#### **Submit High Quality Materials Reflecting Mission and Excellence**

- Recent reviews, videos, awards and recognitions.
- Letters of support from those who can attest to the organization's artistic integrity and contributions.

#### **Showcase Community Impact and Accessibility Efforts**

- Include metrics (e.g., attendance, geographic reach) and examples of community partnerships that demonstrate impact.
- Provide examples of how your programs serve diverse and underserved audiences.
- Emphasize your commitment to ADA compliance and inclusivity.
- If you participate in VCA's Passport Program, let us know!

#### **BUILDING TRUST THROUGH TRANSPARENCY**



#### **Align Numbers with Narratives**

- Ensure your budget aligns with the descriptive impact in your story.
- Document in-kind support and contributions to demonstrate community investment.

#### **Acknowledge Challenges**

- Be open about deficits, staffing changes, or audience declines.
- Share steps you are taking to address these issues with clear plans.

#### **Highlight Accountability**

- Demonstrate how you measure success through data and feedback.
- Include specific evaluation tools and how they inform your decisions.

#### **BEFORE YOU CLICK SUBMIT!**



#### **Proofread and Review**

- Check for typos, errors, or missing details to ensure a polished application.
- Make sure your uploads can be easily viewed.
- Have a colleague review for clarity and alignment with the grant's goals.
- Once you submit your application, it cannot be updated.

#### **Submit Early and Stay Engaged**

- Avoid last-minute submissions—give yourself time to resolve any issues.
- Reach out to grant officers for guidance or clarification if needed.

### NOMINATE ADVISORY PANELISTS



#### **Nominations for Advisory Panels**

The Commission staff reviews nominations submitted via our nomination form that includes a brief description of the individual's experience in the arts, an address, and a telephone number.

#### **Advisory Panelists Possess**

- In-depth knowledge in a field of the arts
- Familiarity and understanding of a wide variety of arts events in their communities
- Willingness to offer opinions and work in a committee setting
- Contribute the time necessary to review grant applications and to understand the Commission programs and guidelines
- Ability to attend a one-day Advisory Panel screening session
- Access to a laptop computer for Advisory Panel application review




